

**SBC Board Meeting Minutes**  
**July 3, 2019, 7:00pm**

President's Remarks: Conducted by Scott Sievers. 1) Scott gave a positive recap of the TOMRV ride where 8 SBC members traveled to and rode the Tour of the Mississippi River Valley ride. Incentive Chair Report: Marty Celnick absent. Scott Sievers recapped the June rides. Troy Gilmore's late afternoon coffee ride was voted ride of the month. On a hot and muggy afternoon, about 8 riders met at the Cantrall Creek parking lot of the Sangamon Valley trail, and rode to Petersburg for 32 round trip miles. I was on that ride. We stopped at a café on the town square for food and drinks then we got back on our bikes and returned to the trailhead parking lot. The ride back was harder than anticipated, as the wind unexpectedly switched directions. Luckily, there were no heat related emergencies.
